Any extension beyond 03 years on yearly basis, but upto the maximum of 05 years of contract shall be with the approval of the NHAI Board. There shall be no extension beyond total 05 years of contract under any circumstances whatsoever. The EEP shall not be engaged with NHAI after the period of 05 years.

6	Essential Educational qualification and experience	Professionals from Open Market, Research Fellows/ Scholars from Educational institutions such as Indian Institutes of Technology (IITs), Indian Institutes of Management (IIMs), School of Planning and Architecture (SPA), National Institutes of Technology (NITs), and other recognized Universities/ Institutions of national and international repute/ADB/World Bank and other multilateral institutions, possessing the following eligibility criteria: (i) Bachelor's Degree in Civil Engineering from a University or Institute; and (ii) Post Graduate Degree or Post Graduate Diploma in Transport Planning from a University or Institute; and (iii) Minimum 5 Years of experience in the field of transport planning/highway planning/ traffic engineering/ mobility planning/modelling, or experience in assessment of transport project, preferably road projects.
